- COC existing project application process is currently ongoing, with the selection having met to evaluate the applications. The ranking and award letter won't be sent out until NOFO is released.

- New projects are still on hold until the NOFO is released at the end of July but the COC funding guide has been published online
- HAWNY announces the COC RFP for Gennesee, Wyoming County to host a committee
  meeting will take place August 11th 9am-12pm in Batavia to discuss planning for helping
  unsheltered individuals, and the impact of the COC applying for rural funding from HUD
