- HMIS Updates
  - **WellSky User Interface Update**: Sometime in July, WellSky is updating their user interface that will change the display in HMIS.
  - **2024 HUD Data Standards change:** Question wording/pick list is changing to more client centered language. New questions being added on the client's sexual orientation and if they need translation assistance. Biggest change is that the Coordinated Entry section is essentially merging into one section.
  - **Project Naming Structure Change:** All project names will now include the funding source and project type. Notify HMIS staff by August 1 if any additional changes are needed to your project name.

- Best Practices for HMIS
  - New Hire readiness
    - Technology readiness such as work email, any type of internal technology orientation or training
  - Agency or Provider onboarding
    - Has the new hire started an internal orientation, onboarding or coaching program? Do they understand their roles and responsibilities and what they will need to do in HMIS?
  - Communicating with HAWNY
    - Letting the employee know what projects they will need access to and if they will be working on the CE process.
  - Managing HMIS projects
    - Identify an Agency Administrator
    - Monitor for data quality issues regularly
    - Do not share user accounts or login information
    - Run the APR every month and correct any errors that are shown

## 4. CoC Updates

- Today, June 21st is the deadline for the NOFO renewal application by 4pm;
- July 10th the selection committee will be meeting to score the renewal application with preliminary results to share;
- June 28 is the YHDP project selection committee meeting date;
- New project information should be out around mid-July;
- There may be a capital project NOFO that will be coming out after the regular NOFO, sometime in the Fall/Winter time period;
- HUD is recommending for new projects to think about partnering with health care support or housing support such as the Public Housing Authority, and Erie County Department of Social Service.
- HAWNY staff will be attending the National Conference to End Homelessness in Washington D.C in July. Staff will have a chance to speak with local representatives on behalf of the CoC. HAWNY will send out a survey to receive feedback from CoC funding agencies about what advocacy needs to be done during the conference.
