## CoC

- NOFA will be submitted tomorrow (Nov.19th) and the Collaborative application and priority listing was posted online yesterday (Nov. 17th)
- Asking the Project Selection Committee to rank projects was like asking to rank children
- HUD never comes out and says don't rank something, but it prioritizes types of projects via point allocations
- Dale asked CoC to keep in mind that the CoC NOFA application is a national competition. Tier 2 project compete within the nation based upon score
- Dale is going through the application now, posted here

  - Weak points
    - Employment outcomes
    - Not all housing authorities having homeless preference. We will continue strengthen our partnership with PHA, Healthcare providers and other housing parners.
    - having folks trained in SOAR HUD wants 75% of agencies with someone trained in SOAR (our goal for the next year)
  - Strong points
    - Integration of five county DSSes (THANK YOU ERIE, NIAGARA, WYOMING, ORLEANS, AND GENESEE COUNTIES!)
    - Mainstream benefits and health care coverage
    - Reallocation from the past 2 years.
  - Dale notes the character limit 1000 for most guestions
  - Highlights
    - Description of coordinated entry, PIT, monitoring, HMIS governance, data quality, AHAR, how you reduce homelessness, exits to permanent housing,
    - Being a Medicaid Expansion state and a Right to Shelter state help us serve clients and score higher (we hope) on this application
- HUD's focus after chronic and veteran's homelessness are families and children
- Started asking about human trafficking issues for the first time
- Dale now going through the priority ranking list.

- Dale notes the size of Tier 2 15% of ARD, made the project selection difficult

- HAWNY voluntarily reduced its HMIS grant \$19,000 so funding could be reallocated towards Coordinated Entry
- Q from Kathleen Heim about how money is spread around the five counties
  - Pro rata need was discussed, the MOU we have when we merge, but the fact that other county's projects also subject to performance and prioritizations

A: We will discuss this in the coming year to prepare for next year's application.

- Q how many PHA in the five counties? Answer: 10
- Recruitment for the Project Selection Committee

  - We'll have quarterly assessment reports and hopefully that will be more helpful
